#### b. Paul Brown-State Adjutant

\*Brought the "Five Rules of Subsidiary Corporations or SAL and Riders Semi Independent Programs" to talk about. There is a new Judge Advocate for National and he interprets things differently than prior Judge Advocates.

\*Theoretically, these will try to be incorporated prior to the next Department Convention in June 2020. Since the Riders operate differently than the SAL at the Department level, Mr. Brown wasn't sure how this would happen. There would needs to be multiple meetings to try to figure all aspects out.

#### For Departments...

- 1. All officers, directors, trustees, etc. must be named by the Department (usually nominated by the Department Commander and confirmed by the Department Executive Committee).
  - \*This does not apply in California.
- 2. All vacancies in the subsidiary corporation must be filled by the Department.
  - \*This does not apply in California.
- 3. The subsidiary corporation must report to the Department, no less frequently than monthly. These reports must include financial reports. \*Chapters should be doing this with their post monthly or quarterly.
- The Department Treasurer or Finance Officer or Department fiscal officer must be a signatory on all accounts.
   \*Chapters should be doing this with their Post finance officer.
- 5. All amendments to articles of incorporation or by-laws must be approved by the Department. (If the current text has not been approved by Department, it too must be approved.)
  \*Already in place in California.

Mr. Brown talked about best practices at Posts. Issues at the Post level effects the Department. When Posts allow 1%ers to rent the Post it makes issues all around.

Paul Patricio talked about who the Posts are allowing to rent their Halls.
