The VA is a federal entity so they cannot ask for a donation so they just show the need. They are in need of about \$15K for another statue. We would like to open this up to chapters to come up with fundraisers to raise this money and then all ride together to present the donation. They will put a plaque on it saying it was provided by the ALR. Anthony explained that due to the rigid budget we do not have the room to make donations for worthy causes such as this. We do not have a line item to

be able to donate. Randy explained he wasn't asking the state foor the money but for each chapter to do fundraisers for this. November 1th is the next dedication but we can donate at any time. Mick asked the Area VP's to see what support they are able to get and we will discuss at the next meeting.

## 5. Good of the Riders

James Adames reminded everyone that September 17 is the Sarah's Cancer ride in Oxnard. The information is already on the Website

John Moffitt is the Western Region Chair. We received an email that included a letter from the National JA with recommendations based on resolutions. National stated that they will not get involved with patches/uniforms and leave it up to the departments. Regarding the COC, The ALR cannot become members of the COC. We cannot go to the club houses and things like that but we can welcome them at our events. Trade Marks, on the legion website we have a form that we have to fill out, requesting to use the emblems. Supporter, Honorary or volunteer status is not valid we only have active or retired. Another section stated just with different wording, our election process. But it does state that post commanders can remove an officer so we are waiting for word from Doc Bart regarding this part. Every Chapter must report to the post no less than 1 time a month. The post Finance officer is supposed to be listed on all SONS and ALR Chapters. Hy Libby asked if this letter can be shared with membership. Bob Perryman expressed concerns for the wording that a post commander can remove ALR officers at will. This leaves it open for Post Commanders who do not like the riders and see them as a threat they can use this to hurt a chapter. Mick stated he will try to get clarification and possibly the State JA to address this next month. Steve Story asked if this is from actual resolution or just someone's opinion. Mick stated he has researched this and cannot find any reference to this so that is why he is requesting clarification. Anthony mentioned we have no ability to fight for changes because we still have not gotten in to compliance with what we were already told to do. James stated that this was just from an advisory committee and we should not worry about this yet. We do already 1-4 and for the number 5 we go one step further with our Trial Manual. Mick stated he does not expect a chapter president to track down every member to check their vest but to address issues as they see them. Regarding bootleg patches it's not the members fault but the person who sold them that patch and represented it as an ALR patch.
